Trustees' report

Structure, Governance and Management

Nature of governing document

The governing document for the charity is a memorandum and articles of association, and the charity is constituted as a company limited by guarantee.

Decision making structure

The Trustees decide the strategic direction for the charity and approve the Strategic Plan and the annual budget. The Chief Executive is delegated day-to-day management and implementation responsibility for the strategy and expenditure within the budget limits. Progress is monitored through quarterly Finance/HR sub-group meetings that include the office bearers and report to the full Board of Trustees.

Appointment of trustees

Members of the Board of Trustees are categorised as individuals. Institutions, organizations, or other bodies are not eligible to be members of the Board of Trustees.

The number of members of the Board of Trustees shall not be less than six and no more than twelve.

Two non-voting Observers from key statutory stakeholders attend meetings of the Board of Trustees.

Policies and procedures for induction and training of trustees

New Trustees are inducted by the Chairman and Chief Executive of the Charity and are provided with key documents outlining their governance roles and responsibilities.

Risk management

The Board of Trustees has adopted a process for the ongoing assessment of possible risks to the organisation and has developed actions and countermeasures to reduce these risks and their likely impact. The risk framework is subject to regular review and biannual updating. The Board is therefore satisfied that systems and actions are in place to mitigate our exposure to major risk.

Objectives and Activities

The company's purpose is to aid the relief of poverty, hardship, suffering and distress among partners, children and dependents of persons who suffered a legal restriction on their liberty in any penal or correctional establishment or through any means whatsoever.

Families Outside is the only national organisation that works exclusively on behalf of children and families affected by imprisonment in Scotland. We exist because imprisonment of a family member has a negative impact on the social, emotional, financial and (for children and young people) educational development of the remaining family members, leading to disadvantage, exclusion and the risk of perpetuation of cycles of crime and imprisonment.

Families Outside works to mitigate the effects of imprisonment on children and families - and consequently to reduce the likelihood of reoffending - through support and information for families and for those working with them. We seek to ensure that these families are afforded the recognition, respect and compassion they need to alleviate the disadvantages they face due to this experience, also enabling them, where appropriate, to provide support to their relative in prison and on release.

Objectives and Activities (continued)

The charity's long term key objectives are to ensure that:

- Families affected by imprisonment can access appropriate information and support at the time they need it. This in turn will improve their experience with the criminal justice system and mitigate its impact on them;
- Policy makers, decision makers, and relevant service providers will be well-informed about the issues facing families affected by imprisonment. They will recognise prisoners' families within their remit and take the needs of these families into account in the decisions they make and the services they provide;
- Families Outside will provide a sustainable and viable service as long as the demand for its work is evident.

In order to achieve these long-term key objectives, our targets include the following actions:

- Raise awareness and influence policy and practice regarding families affected by imprisonment;
- Provide and increase direct support and information to families;
- Support and collaborate with other organisations to support families; and
- Ensure viability, effectiveness and impact of the organisation.

These aims are essential and ongoing and are facilitated by specific, often ongoing, activities that Families Outside is engaged in throughout the year. These activities help us in achieve our long-term key objectives and include:

Ongoing core activities:

- Operation of the Families Outside national freephone Support & Information Helpline, supporting 1,800+ families and professionals per year;
- Direct service provision through our Family Support Workers to families affected by imprisonment. Extending to the whole of Scotland, the six members of staff have an annual caseload in excess of 300 per annum (higher than the targeted 200 families). These 300 families include about 700 individuals adults and children), though this is growing with the addition of prison visitors' centres at some prisons.
- Direct provision of support/information to families at our own prison visitors' centre at HMP Addiewell;
- Development work in schools to support children affected by a family member's imprisonment;
- Management and support of our volunteer pool, increasing our capacity to work in different areas;
- Training/awareness-raising to prison staff, teachers and trainee teachers, police, Children's Panel Members, social workers, students, the National Health Service and more. This includes a very popular programme of CPD for teachers delivered in prisons and SkillsMark accredited training on child protection and the impact of imprisonment on children. Overall, we provided training to about 5,000 people in 2013/14 throughout Scotland double last year's figure;
- Resources for families and professionals: publications, on-line resources such as videos (available through our Vimeo account, quarterly newsletter, website (including specific information for children/young people), as well as regular updates through social media Facebook and Twitter;
- Development of policy and practice alongside national and local statutory organisations, contributing through consultations, steering & advisory groups relevant to families and our Cross-Party Group on Children & Families Affected by Imprisonment. We also actively seek development of policy and practice in Scotland internationally through membership of Children of Prisoners Europe (COPE) and involvement in the UN Committee on the Rights of the Child.
- Publicity distributed to families affected by imprisonment and a wide range of professional contacts including courts/prisons/CABs/social work departments. This includes leaflets, professional packs, downloadable materials from our website and, in development, web-based training/eLearning resources;
- Regional contact through our Regional Coordinators who link with prisons, Community Justice Authorities and locally based statutory and voluntary support services. This ensures our influence spreads throughout Scotland, allowing us to act effectively as a national umbrella organisation for services offering support to families affected by imprisonment;
- Support for other organisations working with families through cross-referral, training, evaluation and sharing of information and practice, particularly through coordination and chairmanship of the Criminal Justice Family Support Network; and
- Exhibitions/presentations/workshops at conferences and other events.

Objectives and Activities (continued)

- Held a successful national conference for 200 delegates in May 2013 entitled 'Them and Us?': Victims, Offenders, Communities, and Families Affected by Imprisonment;
- Continuation of the New Routes Public Social Partnership (previously Routes out of Prison), led by the Scottish Prison Service and the Wise Group;
- Continuation of The LifeTime project following its continued success in recent years. This is an initiative
 run by the Scottish Prison Service in collaboration with the police, Scottish Court Service, the fire service,
 The Red Cross, and ourselves, among other partners, to make young people in secondary schools aware of
 the impact of offending;
- Completion of a web-based training resource on the impact of a family member's imprisonment on young people as well as additional tools such as the 'Reversible Thinking' video which can be viewed by visiting www.familiesoutside.org.uk/reversible-thinking-video;
- Development of a protocol for support to families affected by imprisonment, funded by Lothian & Borders Community Justice Authority;
- Publication of an information booklet for health professionals on their role in supporting children affected by imprisonment;
- Completion of research commissioned by Scottish Government Youth Justice on support to families of young people in secure care;
- Jointly with the Scottish Prison Service, organising and hosting of a two-day workshop for professionals on trauma-informed practice, with international expert Dr. Stephanie Covington, sponsored by the Women at Risk coalition;
- Publication of two new editions of *In Brief* on the financial impact of imprisonment on families and the role of families in desistance from offending; and
- Continuation of development work on support to children of prisoners through schools.

Achievements and performance

Families Outside's profile and reputation are well-established, with positive relationships built with key statutory and voluntary agencies in the criminal justice sector and beyond. This has been aided by the opportunity to contribute actively to a range of Scottish Government and Scottish Prison Service policy and practice initiatives. Our hosting of the Cross-Party Group on Children & Families Affected by Imprisonment continues to play a significant role in this, this year including a special evening event about family impact assessments that included contributions from the judiciary, children's rights advocates, and family members. The end of the financial year focused on preparations for the Children of Prisoners Europe conference (COPE; previously the European Network for Children of Imprisoned Parents - EUROCHIPS), hosted for the first time in Edinburgh in May 2014.

The Regional Coordinators and Chief Executive work closely with the Scottish Prison Service and Scotland's eight Community Justice Authorities (CJAs) to assist in the development and implementation of policy and practice with regard to prisoners' families, including chairmanship of Family Outcome Groups for the two CJAs that have them. This includes delivery of training at individual prisons regarding the impact of imprisonment and child safeguarding. Our Continuing Professional Development for teachers and trainee teachers is gaining momentum and is now delivered in 12 of Scotland's 15 prisons. This training, regarding the impact of imprisonment and the role of schools in supporting the children and families affected, has notably increased referrals to our Helpline and to our Family Support Team throughout the country. We were also able to contribute to a week-long international training programme at the Wells of Hope Academy in Uganda and presented a paper about our work with schools at the European Society of Criminology conference. Significantly, we were also able to deliver training for the first time to judges at the Judicial Institute in March 2014 and have been invited to do this again in October 2014.

Families Outside's Support & Information Helpline continues to provide a direct service to families in need and to the professionals who work with them. It also underpins the organisation's influencing activity through provision of current, direct information about the experiences of people with family members caught up in the criminal justice system. We use feedback from the calls to inform the Scottish Prison Service and other relevant bodies of the issues callers raise and to identify and highlight good practice. Callers can access the Helpline through its freephone telephone number, via e-mail and by text. We are also increasing our use of social networking such as Facebook and Twitter, which provides valuable interaction with service users and professionals alike. We now have almost 1,000 'followers' on Twitter which is increasing its value to us as a means of campaigning and communication.

Achievements and performance (continued)

In addition to our social networking sites, we continue to develop our website to respond to the needs of the families we support. The website is a primary means for callers to learn about the Helpline, and we are working with a new member of our Board with marketing expertise to streamline the content of the site. This year we restructured the site to make it easier to navigate. We have also drafted initial proposals to engage with young people to revamp the 'Kids' section of the site – something we hope to take forward in 2014/15.

Our provision of direct support to families of prisoners continues to move from strength to strength: in the 2012/13 financial year, our Family Support Workers received 274 referrals, with the total number of family members totalling 693 (421 adults and 218 children) – a slight decrease from the previous year, but unsurprising due to a 6-month gap in part-time maternity cover. Numbers for 2013/14 will be considerably higher, not least due to the in-depth contact with 80 families each month at our Prison Visitors' Centre at HMP Addiewell, which opened in January 2013. Family Support Work through Families Outside provides holistic, solution-focused support designed to meet the needs of the individual family members. The report for 2013/14 will be available early in July 2014.

Meanwhile, our staff numbers have increased dramatically and our staffing and management structures have changed along with this. The increased numbers have enabled us to allocate additional staff to the work at the prison visitors' centre at HMP Addiewell and to rationalise the division of labour across geographic regions. For example, we now have dedicated Regional Coordinator/Family Support staff for the Northern and Tayside areas (one for each area). We also hosted a secondee from the Scottish Prison Service to develop our work with volunteers. This work established a pool of volunteers to support the work at Addiewell as well as to start a new service in Edinburgh Sheriff Court.

Finally, our engagement with families in more creative ways has extended this year to include free relaxation sessions and massage for families in the Edinburgh area as well as a series of music workshops for families in HMP Addiewell in collaboration with creative arts-based charity Vox Liminus. We also had the pleasure of supporting the development of the Inside-Out peer support group in Oban.

Financial review

The Statement of Financial Activities shows that Families Outside ended the year with a surplus of £34,684 which compares with a surplus of £14,896 for the previous year. This surplus is made up of the following:

- a restricted deficit of £5,760 relating to:
 - a. expenditure of £1,091 on depreciation from income received from The Kelly Charitable Trust which was carried forward to cover depreciation on capital items acquired in 2012/13;
 - b. expenditure of £5,702 on child/teacher related training from income received from LankellyChase Foundation which was carried forward in restricted reserve from 2012/13;
 - c. expenditure of £8,023 on project costs for schools utilized from income received from The Big Lottery "Awards For All" which was carried forward in restricted reserve from 2012/13.
 - d. underspend of £1,516 on research project funded by Scottish Government Procurement to be placed in restricted reserve and used in continuation of the research project in 2014/15.
 - e. the balance of £7,000 on the In Tune project funded by Scottish Government and BLF Communities and Families Fund to be placed in restricted reserves and used in continuation of the project in 2014/15.
 - f. £540 received from Edinburgh Airports in March 2014 and held in restricted funds, which will be used in 2014/15.
- an unrestricted surplus of £40,444. This means that our unrestricted funds have increased from £151,442 as at 31 March 2013 to £191,886 at 31 March 2014.

The financial position and the review of financial systems and controls of the organisation are monitored on a quarterly basis by a Finance/HR sub-group, which reports to the Board of Trustees.

With funds from these organisations, we have continued to meet the main objectives of Families Outside through the core activities and projects of the charity as detailed above.

In addition, we would like to thank The Michael & Shirley Hunt Charitable Trust, The Albert Hunt Trust, The Gordon Fraser Trust, St Paul's & St George's Church 10% Fund, Edinburgh Airport Community Board, Waitrose, Cash For Kids, the Friends of Families Outside and everyone else who made donations and supported our activities throughout the year.

Reserves Policy

The unrestricted fund balance is £191,886, of which £189,255 represents the free reserves of the organisation arising from past operating results. The Board would like to apply 'best practice' and maintain the free reserves to a level which would cover about three to six months forecast operating activity, a target which has now been achieved at the lower to mid-end.

Plans for future periods

In the forthcoming 2014/15 financial year, Families Outside will commit itself to the following activities:

- Host a European conference and smaller events to raise awareness of the impact of imprisonment and engage support in addressing this.
- In collaboration with the Community Justice Authorities, complete and implement a protocol for support for families affected by imprisonment.
- Continue campaigning through the Parliamentary Cross-Party Group regarding Scotland's treatment of children with imprisoned parents.
- Continue to promote the Helpline as a resource for families and for professionals who can call on our specialist knowledge to assist them in their own work with families.
- Continue to provide direct support to families of offenders throughout Scotland, including through our new services such as the prison visitors' centre at HMP Addiewell and the Emergency Discretionary Fund for families in crisis.
- Explore and consolidate support for families in relation to travel for prison visits.
- Continue to train staff from a wide range of backgrounds who come into contact with families e.g. the Scottish Prison Service, staff at private prisons, teachers and trainee teachers, Children's Panel members, NHS, police, schools, courts, social workers, students of social work and forensic psychology, and secondary school students.

Plans for future periods (continued)

- Linking with prisons, continue to develop work within schools to support children of prisoners.
- Using the new booklet for health professionals, and the CPD for teachers as a template, target health professionals to raise awareness of the issues surrounding families affected by imprisonment.
- Continue the development of online resources for professionals in justice, education, health and other sectors.
- Through the new National Prison Visitors' Centre Steering Group, continue to support the development of prison Visitors' Centres.
- Continue to promote the development of play provision in prisons and deliver training to prison staff in this
 area.
- Continue direct development of policy and practice through participation in the national and regional Scottish Prison Service Children & Family Strategy Groups, Community Justice Authorities, the Scottish Working Group on Women's Offending, the Scottish Consortium on Crime and Criminal Justice, and the Scottish Criminal Justice Voluntary Sector Forum as well as lobbying of Members of the Scottish Parliament and engagement with international bodies such as Children of Prisoners Europe.
- Identify and promote the use of new and existing tools to conduct Child & Family Impact Assessments.
- Provide further opportunities for family members to come together, talk and listen in a safe environment and feed more directly into our work.
- Produce *In Brief* 11 on support for families with a young person in secure care.

Auditors

We have audited the financial statements of Families Outside for the year ended 31 March 2014 which comprise the statement of financial activities, the balance sheet and the related notes. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

1 Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention, and are in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Statement of Recommended Practice - Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) issued in 2005; the Charities and Trustee Investment (Scotland) Act 2005 and the Companies Act 2006.

The Board consider it is appropriate to draw up the accounts on a going concern basis as sufficient funding has been secured to cover operational costs for the 12 months from the date of the accounts. The Board is actively seeking funds for the following 12 months and beyond.

Incoming resources

- Incoming resources are included in the year in which they are receivable, which is when the company becomes entitled to the resource.
- Grants receivable are credited in the year for which they are received.
- Income that relates to future periods as a result of donor imposed conditions specifying the time period has been treated as deferred income.
- Income relating to the acquisition of fixed assets has been recognised as restricted income against which the appropriate depreciation will be charged.

Resources expended

All expenditure is included on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure. The company is not registered for VAT and accordingly costs are shown gross of irrecoverable VAT. Where directly attributable, resources expended are allocated to the relevant functional category. Overhead and support costs are allocated to functional category on the basis of direct staff costs in each area of activity.

• Cost of generating funds

The costs of generating funds include expenditure incurred in supporting the charity and incurred on fundraising initiatives

• Charitable activities

The costs of charitable activities include expenditure incurred in supporting the charity and its objectives as set out in the directors' report.

Governance costs

Governance costs are those incurred in connection with the, organisational administration and compliance with constitutional and statutory requirements.

Fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Assets below £200 are not capitalised but are expensed in the year they are incurred. Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows: Equipment – 25% straight line

Pensions

The company contributes to employees' individual pension plans. The amounts charged against the income and expenditure account represent the contributions to the defined contribution scheme and to individual pension plans in respect of the accounting period.

Leases

Operating lease rentals are charged to the profit and loss account on a straight line basis over the lease period.

Funds

Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the company without further specified purpose and are available as general funds. Restricted funds are to be used for specific purposes as laid down by the donor. Expenditure which meets these criteria is charged to the fund, together with a fair allocation of management and support costs.
