Nancy Loucks OBE CEO Families Outside



Prof. Nancy Loucks OBE is the Chief Executive of Families Outside, a Scottish voluntary organisation that works on behalf of families affected by imprisonment. Prior to this she worked as an Independent Criminologist, receiving her MPhil and PhD from the Institute of Criminology at the University of Cambridge, and in 2012 was appointed as Visiting Professor at the University of Strathclyde's Centre for Law, Crime and Justice. Nancy was awarded an OBE in the 2016 New Year's Honours List for services to Education and Human Rights. She co-chaired the Justice & Care Workstream for the Independent Care Review and the Independent Review of the Response to Deaths in Prison in Scotland; chairs the Board of the International Coalition for Children of Incarcerated Parents (INCCIP); and is a member of the Global Prisoners' Families Research Group at the Centre for Criminology, Faculty of Law, University of Oxford.

Sarah Beresford Prison Reform Trust



With a background in education, Sarah joined Families Outside from 2012 to 2015 to focus on improving support for children and young people with a family member in prison. Since 2016, Sarah has been an Associate of the Prison Reform Trust. She has written several reports focused on women in prison, including What about me?, which explores the impact on children when mothers are involved in the criminal justice system. Sarah is currently leading a project, funded by the Churchill Fellowship, looking at the use of Child Impact Assessments for children with a parent in the criminal justice system to ensure children are listened to and receive the support they need.

Sarah is a Trustee of <u>LDCSA</u>, a charity that provides accommodation and support to women leaving prison and an advisor to <u>Time-Matters UK</u>, a Liverpool based support group for children with a family member in prison. Sarah is committed to ensuring children and young people are included in the development of resources to support them and is passionate about seeing the potential in people and enabling them to become their best selves.

Linda Bendle Chair of Families Outside



Linda is the Chair of Families Outside and is a family member of someone who has been affected by imprisonment. She is Head of Business Development & Operations at Heavy Sound, a community interest company which re-engages disengaged, disadvantaged young people through music, biking, sports and mentoring projects, as well as mentoring young people and adults involved in the criminal justice system. Linda is also on the board of Community Justice Scotland, Shelter Scotland and Recovery Coaching Scotland.
